### Economic Outlook H2/2023 Workshop

Hanoi, September 8th 2023

On Friday, 8th September 2023 in Hanoi, with the support of BritCham Vietnam, VBF successfully organized the Vietnam Economic Outlook H2.2023 with participation of more than 300 people both in person and via online. This inaugural Vietnam Economic Outlook event marks the beginning of a significant annual VBF event within business community in the coming time.

Presented at the event, VBF Co-Chair Nitin Kapoor emphasized that the first half of 2023 witnessed an economic growth rate of 3.72%, which, though not exceptionally high, stands as a testament to Vietnam's stability. Vietnam's macroeconomy remains secure and inflation is under control.

Regarding the latest draft decree to replace Decree 72/2013/ND-CP on the management, provision and use of Internet services and online information and Decree 27/2018/ND-CP which amends Decree 72, VBF Digital Economy Working Group has submitted its recommendations/ comments to the Authority of Broadcasting and Electronic Information (Ministry of Information and Communications - MIC) for their consideration. As planned, the official Decree will be approved and issued in October 2023.

VBF Human Resources Working Group



### **Banking Working Group's activities**

1.Law on Credit institutions (LOCI) Drafting session of NA' Economic Committee:

From August 30 to September 11, 2023, BWG Secretariat & representatives attended the meeting on reviewing the 4th Draft LOCI with the SBV's drafting team, NA Economic Committee and respective ministries (MOF, MOJ, etc.). BWG also joined

another meeting on the 5th Draft LOCI with the above-mentioned related parties on September 21, 2023. These close discussions helped to effectively convey BWG opinions to the regulators.

#### 2. VNBA's workshop on Anti-Money Laundering

BWG representatives presented some key issues in regard to Circular 09/2023/TT-NHNN and Decree 19/2023/NĐ-CP guiding AML Law on workshops on Regulations on Anti-Money Laundering and the Role of Anti-Money Laundering in E-Transactions held by VNBA, in collaboration with BlockChain Vietnam Association, on September 20 in Hanoi and 22 in HCMC, respectively.
