# TAX & CUSTOMS WORKING GROUP'S ADVOCACY SERIES ENGAGEMENTS WITH GOVERNMENT COUNTERPARTS

To kick-off the 2025, the Tax & Customs Working Group held its regular dialogues with the Department of Customs (previously the General Department of Customs - GDC) on January 10, 2025, and the Department of Tax (previously the General Department of Tax - GDT) on February 12, 2025, at their headquarters.

#### Working Session on Customs issues:

Chaired by Leader of Customs Reform and Modernization Board with participation from key functional departments, including the Legal Department, Post-Clearance Audit Department, Customs Control and Supervision Department, and the Import-Export Duty Department.

Representing VBF, the discussion was led by Ms. Huong Vu, Head of the Tax & Customs Working Group, and Mr. David John Whitehead, VBF Board Member.

The discussions covered a range of topics and challenges identified by enterprises, offering a platform for businesses to provide input and receive direct feedback from policymakers.

#### Working Session on Tax issues:

Chaired by Mr. Đặng Ngọc Minh, Deputy General Director of GDT, with the participation of key leaders from GDT, its departments, and provincial tax departments.

Leading the discussions on behalf of VBF were Ms. Hương Vũ, Head of the Tax & Customs Working Group, and Ms. Virginia Foote, VBF Board Member. The meeting brought together over 100 representatives from foreign-invested enterprises (FDIs), highlighting the strong engagement between businesses and tax authorities.

Under the moderation of Mr. Minh, the session conducted a thorough and insightful discussion of all taxation-related cases raised by VBF members, ensuring each issue was carefully examined. The dialogue provided businesses with direct access to GDT leaders, enabling them to present their challenges and receive immediate guidance and clarifications.

# BWG HIGH-LEVEL MEETING WITH DEPUTY GOVERNOR PHAM THANH HA AND DEPARTMENTS UNDER THE STATE BANK OF VIETNAM

- Monetary policy management to support growth and stability.

- Strengthening supervision and preventing financial violations.
- Promoting digital transformation and financial security

On behalf of over 40 BWG members, Mr. Kojima Masao expressed gratitude for the SBV's support in maintaining an effective policy dialogue. He acknowledged the SBV's effective measures navigating policy in economic challenges, stabilizing the macroeconomy, controlling inflation, and contributing to sustainable economic growth despite global uncertainties. 




## VIRTUAL BRIEFING ON MPS DRAFT DOCUMENTS DETAILING DATA LAW


